An exhibit at the Denver National Quilt Show sponsored by Mancuso Brothers April 29 - May 2, 2010

Here's your chance to share your quilt with the people of Denver! A juried exhibit of approximately 40 quilts made by CQC members will be displayed at the Mancuso Brothers Show, Denver National Quilt Festival, from April 29-May 2, 2010. Let's show the people of Colorado what CQC members can do!!!

Quilts will be juried by the CQC exhibits committee. The bottom half of the entry form and a photo of the quilt need to be mailed to Sandy Wheeler by March 30. (A digital photo may be emailed to her at: [angelthings@comcast.net](mailto:angelthings@comcast.net)) Acceptance letters will be e-mailed by April 9, and those quilts selected for the exhibit need to be delivered to Sandy Wheeler in person or mailed to her home (4686 Van Gordon Ct., Morrison, CO 80465 303-978-9637) to arrive by April 21. Quilts can also be delivered to Sandy at the April 24 meeting in Pueblo. Participants (or a designated person) need to pick up quilts from Sandy by May 21, or, if \$19.50 postage is included with the entry form, it will be mailed back to the entrant. (If you wish to purchase insurance, check with the post office to get the insurance amount and include that amount in your check plus the \$19.50.) **Quilts can also be picked up at the CQC meeting on May 22 in Golden.** Please be sure that your quilt has a 4" sleeve on the top of the back side and put your quilt into a cloth bag or pillowcase. Make sure your quilt has a label with your name on it. Also please put your name on the cloth bag. **Quilts in plastic bags will not be accepted!**

Complete this form and attach it to your quilt. Please put the quilt in a cloth bag or a pillowcase that has your name on it. Deliver your quilt to Sandy in person or mail it to her at 4686 Van Gordon Ct., Morrison, CO 80465 (303-978-9637).
